What is a minor amendment?

- A change of Environmental Authority conditions (conditions conversion).
- A minor increase in environmental harm, scale or intensity caused by the Environmentally Relevant Activity.
- An increase of less than 10% surface area used by the Environmentally Relevant Activity.

What is a major amendment?




- A significant increase in scale or intensity of the Environmentally Relevant Activity
- An increase of more than 10% of surface area used by the Environmentally Relevant Activity.
- An increase in degree of environmental harm caused by the Environmentally Relevant Activity.
