Policy objective:

To embed the application of Principles of Sustainability into Council’s decision making and activities in a manner where environmental, community, economic and governance responsibilities are equally considered as part of decision making and activities, to meet the needs of the present and create a foundation for future generations to meet their own needs.

Policy scope:

This is a whole-of-Council Policy that requires Council and its employees to consider Principles of Sustainability in their decisions and activities across all areas of Council business.

Definitions:

Principles of Sustainability	Logan City Council’s Principles of Sustainability are: Environment - Council will deliver services and activities in a manner that avoids and reduces waste, energy consumption and carbon emissions; is water efficient; uses recycled or reuseable goods wherever practical and protects and enhances our natural environment, while considering the social, economic and governance implications of decisions. Community - Council will ensure access to services, facilities and amenities that promote a community that is healthy and active; inclusive and connected and safe and resilient, while considering the environmental, economic and governance ramifications of decisions.
