A person who is or becomes an unsuitable person, will have their application refused or cancelled.

- a member of the Animal Compliance Team will contact me to discuss my application and arrange an inspection
- I must abide by the *Animal Management (Cats and Dogs) Act 2008* and all relevant Logan City Council local laws to maintain my approval
- all resident dogs over the age of three (3) months must be registered with Logan City Council
- registration for all resident dogs must be renewed yearly.

I agree to ensure that keeping dogs under this approval:

- does not cause a nuisance or a risk to human health and safety
- is consistent with the rights, expectations and enjoyment of the local community

- the approval is issued to the person and property named in this application
- the approval is NOT transferrable between properties
