
Logan City Council's Environmental Conservation Partnerships (ECP) provide support for private landowners to protect the ecological and conservation values of their land for the future.

Council provides both financial and material support to landowners who are willing to integrate conservation land management practices with their existing land uses.

This support is available through a range of completely voluntary agreements. These agreements vary significantly in terms of the level of commitment of the landowner, and our current membership includes primary producers, schools, retirees, businesses, young families and more.

Benefits of the program include*:

- · free to join
- free annual incentives package (may include a choice of plants, nest boxes, books, mulch etc.)
- free ongoing land management support and advice (eg. habitat restoration, weed management, wildlife and plant identification)
- free environmental workshops, field days and networking events
- free land and wildlife management notes and quarterly newsletters
- free property sign.
- *not all benefits are available to all agreement types.
