Part 1 Preliminary

1 Short title

This subordinate local law may be cited as *Subordinate Local Law No. 6.1 (Smoke Free Places) 2015*.

2 Authorising local law

This subordinate local law is made pursuant to *Local Law No. 6 (Smoke Free Places) 2015*.

3 Object

The object of this subordinate local law is to assist in the implementation of *Local Law No. 6 (Smoke Free Places) 2015* by specifying those matters that are necessary for the implementation of smoke free places in the local government area.

Part 2 No smoking requirements

4 Smoke free places

For the purposes of section 5(1) (Declaration of a smoke free place) of *Local Law No. 6 (Smoke Free Places) 2015*, those parts of the local government area that are declared to be a smoke free place are those described in Schedule 1 (Smoke free places) of this subordinate local law and are contained within a red dashed line in Schedule 1 (Smoke free places) of this subordinate local law.

5 No smoking sign

For the purposes of the Schedule (Dictionary) of *Local Law No. 6 (Smoke free places) 2015*, a sign is a no smoking sign if it contains a symbol similar to the symbol below.

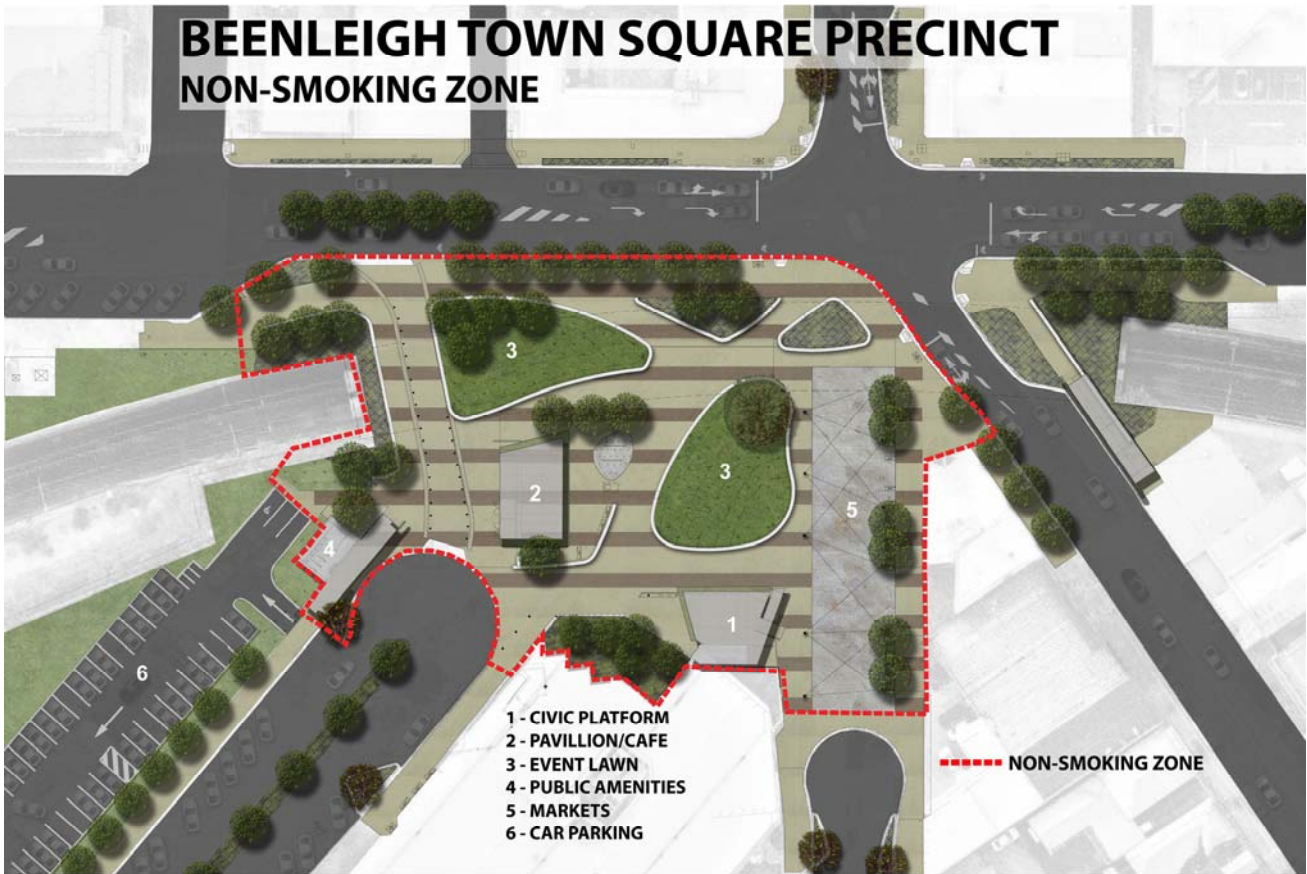
