Part 1 Preliminary

1 Short title

This subordinate local law may be cited as *Subordinate Local Law No. 12.7 (Depots) 2003*.

2 Authorising local law

This subordinate local law is made pursuant to *Local Law No. 12 (Council Property and Other Public Places) 2003*.

3 Object

The object of this subordinate local law is to assist in the implementation of *Local Law No. 12 (Council Property and Other Public Places) 2003* by specifying pursuant to section 9(1) (Regulation of council property) of *Local Law No. 12 (Council Property and Other Public Places) 2003* restrictions on the use of depots.

4 Definitions—the dictionary

The dictionary in Schedule 2 (Dictionary) of this subordinate local law defines particular words used in this subordinate local law.

Part 2 Visitors to depots

5 Admission to restricted area

A person must not enter a restricted area, unless authorised by—

- (a) the prior written approval of a council officer; or
- (b) a direction of an authorised person.

6 Regulated conduct

A person must not—

- (a) use indecent, obscene, insulting or threatening language in a depot; or
- (b) behave in an offensive, threatening or indecent manner in a depot; or

- (c) by disorderly conduct cause serious alarm or affront to a person in a depot; or
- (d) obstruct a council officer in the performance of that council officer's work or duties in a depot; or
- (e) cause annoyance or inconvenience to any other person in a depot; or
- (f) stand or loiter to the inconvenience, annoyance or obstruction of any person in a depot; or
- (g) carry or convey any article or substance of an offensive or indecent character or any article of any length or dimension as to be an inconvenience, obstruction, hazard or danger to any person in a depot other than an article or substance intended to be lawfully disposed of at a depot; or
- (h) place or cause or permit to be placed in a depot anything whatsoever so as to be an inconvenience, obstruction, hazard or danger to any person in a depot; or
- (i) push into any line of persons in a depot that has been fixed by an authorised person; or
- (j) obstruct, hinder or prevent the free passage of any person or vehicle in a depot; or
- (k) do or say anything to hinder or interfere with the proper progress or conduct of an authorised activity in a depot; or
- (l) contravene any restriction to which the person's entry to a depot was subject; or
- (m) enter any part of a depot when excluded or banned by the direction of an authorised person; or
- (n) remove an animal from a depot without the approval of an authorised person; or
- (o) remove an animal from a depot without paying a general charge that is required to be paid by that person in relation to the removal of that animal from the depot; or
- (p) leave an animal at a depot without providing the information prescribed by a council officer in relation to the leaving of that animal at a depot; or
- (q) take food for human or animal consumption into any area of a depot where animals are housed; or

- (r) allow a person, who is a minor who is under their control, to be unsupervised in any part of a depot where animals are housed.

7 Recreational activities

A person (other than a council officer acting in the course of the council officer's employment) must not, unless authorised by the prior written approval of the local government or a direction of an authorised person—

- (a) make an address or conduct or hold a meeting or musical performance, an amusement or any other event in a depot; or
- (b) have or operate in a depot—
 - (i) television, cinematographic or photographic equipment; or
 - (ii) a radio, cassette or other audio equipment or amplifier device; or
 - (iii) an audio or video recorder; or
 - (iv) other audio or visual recording device; or
- (c) operate any radio, cassette or other audio player, or play any musical instrument at a volume likely to cause annoyance or inconvenience to any person in a depot; or
- (d) drive, stand, wheel or park any regulated vehicle in a manner likely to cause annoyance or inconvenience to any person in a depot.

8 Liquor not to be brought into a depot

A person (other than a council officer acting in the course of the council officer's employment) must not bring liquor into any public area of a depot, unless authorised by—

- (a) the prior written approval of the local government; or
- (b) a direction of an authorised person.

9 Smoking

A person must not smoke within—

- (a) an enclosed part of a depot; or
- (b) 4 metres of an entrance to a building at a depot.

10 Littering

- (1) A person must not deposit or discard any rubbish, litter or waste of any kind in a depot (other than in a waste container).
- (2) A person must not deposit or discard any rubbish, litter or waste which is generated on premises (other than a depot) in a waste container situated in a depot.

11 Interference with signs

A person (other than a council officer acting in the course of the council officer's employment) must not interfere with any sign exhibited in a depot.

12 Directions

A person must comply with a direction of an authorised person made or given for the purpose of securing the good order, management or enjoyment of a depot.

13 Distribution of publications

A person (other than a council officer acting in the course of the council officer's employment) must not distribute a publication in a depot, publicise a publication or engage in any promotional activity in a depot unless authorised by—

- (a) the prior written approval of the local government; or
- (b) a direction of an authorised person

14 Interference with a depot

A person (other than a council officer acting in the course of the council officer's employment) must not, unless authorised by the prior written approval of the local government, interfere with—

- (a) a good in a depot; or
- (b) any rock, soil, sand, stone, plant or similar substance in a depot; or
- (c) a council asset in a depot; or
- (d) any part of a depot.

15 Erection of structures

A person (other than a council officer acting in the course of the council officer's employment) must not erect any building, structure, stall, booth, tent or bar in a depot, unless authorised by the prior written approval of the local government.

Part 3 Vehicles in a depot

16 Access by vehicles

A person must not, unless authorised by the prior written approval of the local government or a direction of an authorised person, drive, lead, stand, wheel or park a vehicle in a depot other than in—

- (a) a designated vehicle area; or
- (b) an area which is intended to be used for public access by a vehicle.

17 Compliance with signs

A person must not, unless authorised by the prior written approval of the local government or a direction of an authorised person, cause a vehicle to be driven, lead, stood, wheeled or parked contrary to a sign in a depot. Signed speed limits must be complied with at all times.

Schedule 2 Dictionary

section 4

amplifier device means—

- (a) a loud hailer; or
- (b) a megaphone; or
- (c) a public address system; or
- (d) a remote telephone bell; or
- (e) a telephone repeater bell.

animal has the meaning given in the local government's animal management local laws.

authorised activity means an activity authorised by the local government or an authorised person to occur in a depot.

council officer has the meaning given in *Local Law No. 2 (Administration) 2010*.

depot means the premises specified in Schedule 1 (Depots) of this subordinate local law.

designated vehicle area means the area which may be used for driving, leading, standing, wheeling or parking a vehicle in a depot that is specified by a sign or as directed by a council officer.

hazard has the meaning given in *Local Law No. 2 (Administration) 2010*.

liquor has the meaning given in the *Liquor Act 1992*.

minor means a person who is less than 16 years of age.

public area means any part of a depot that—

- (a) comprises open space; or
- (b) is used for the purpose of a foyer, walkway or other facility of a public nature.

restricted area means—

- (a) any part of a depot that is not a public area; and
- (b) any part of a depot (including a public area) that is specified as a restricted area by a sign or an authorised person.

waste has the meaning given in the *Environmental Protection Act 1994*.

waste container means a weatherproof container for the storage of waste that—

- (a) is vermin proof; and
- (b) can be readily cleaned; and
- (c) is constructed of durable material; and
- (d) is non-reactive with the intended contents; and
- (e) is leakproof; and
- (f) minimises the loss of material into the environment.
