

# CONSTRUCTION UPDATE: Chambers Flat Road Upgrade

September 2023

**SEE Civil is the appointed contractor to construct the Chambers Flat Road upgrade between Mount Lindesay Highway to just north of Kings Way.**

## NORRIS CREEK ROAD INTERSECTION

From mid-September 2023, upgrading of Norris Creek Road intersection will be delivered in 3 stages over approximately seven weeks, subject to weather and site conditions.

**24-hour traffic lights will operate at the intersection to assist with roadworks and motorists' safety.**

### STAGE 1 - PREPARATION

Northern excavation and earthworks.  
Single lane in and out of Norris Creek Road North  
Duration approx. 1 week.



### STAGE 2 – PRIMARY WORKS

Southern excavation and earthworks.  
Single lane in and out Norris Creek Road South.  
Duration approx. 1 week.



### STAGE 3 – FINISHING WORKS

Full intersection requirements.  
Duration approx. 5 weeks.



## CURRENT WORKS

### ZONE 1 & 2

- increasing the road height for flood resilience
- sealing and asphaltting permanent pavements
- excavating and gravelling driveways
- placing temporary materials to maintain property access during crossover works
- installing the new drainage system
- road reserve works
- delivering or removing equipment, plant and materials
- sealing and asphaltting works
- switching traffic to the new alignment
- removing unsuitable foundation soils.

### ZONE 3 - NORRIS CREEK BRIDGE

- Increased truck movements will occur to remove 'preload' materials from the new Norris Creek bridge abutments which have settled to the right height ahead of schedule.
- Preliminary works to enable construction will be followed by pile driving next month.

### ZONE 4 WORKS

- earthworks and landscaping
- constructing driveways
- delivering or removing equipment, plant and materials
- tying in new section of Chambers Flat Road at Kings Way
- undertaking extensive remedial works on eastbound pavement in coming months to replace unsuitable foundation soils.

## ZONE 4 - IMPORTANT TRAFFIC CHANGES

The first new section of Chambers Flat Road has opened to westbound traffic from Riverina Court to Grevillea Road.

Traffic travelling east from Kings Way towards Carter Road will still use the existing Chambers Flat Road lane.

The right-hand turn out of Kings Way into Chambers Flat Road is closed for around four weeks, to allow the new Kings Way intersection to be built. The right turn from Chambers Flat Road into Kings Way is also closed for this time.

For the safety of motorists and work crews, these changes require continued operation of temporary traffic lights at Kings Way and Riverina Court.

## SEE IT — REPORT IT

We are encouraging motorists, residents and our crews to report registrations of vehicles offending in the work zone to Police.

Please drive with care and comply with road signs and the requests of traffic controllers there to assist and direct road users and pedestrians safely within the work zone.

## WHAT TO EXPECT

- temporary traffic changes — reduced speed, assisted property access, traffic controls and direction of traffic to allow shifting of plant and equipment
- frequent lane adjustments and changed alignments
- letterbox notification of any interruptions to water supply
- odour during asphaltting and sealing works
- increased truck movements
- temporary changes to property access
- changes to waste bin collection to accommodate the eastbound closure
- increased noise, dust and vibration
- weather and site conditions may impact works and scheduled start and finish times
- drone flights will occur intermittently throughout the project.

## TRAVELLING SAFELY THROUGH ROAD WORKS

In response to illegal eastbound travel on the westbound one-way lane, we have taken additional measures for the safety of road users and work crews.

As safety is our priority, we have installed more signs, directional arrows and devices along the one-way detour and on approach to the Chambers Flat Road eastbound lane closure.
