

2024/25 Application for Bulk Bins – Commercial Ratepayers

Service Information

1,100 litre bins are plastic with wheels. All other bins are metal without wheels. Bulk bins are serviced on property, so access to the bin must be clear.

An officer from Council's Waste branch may inspect to check access and bin placement before the service starts. We will contact you if required.

This application must be accompanied by a signed road pavement indemnity (on pages 3, 4 and 5).

If we can't provide the service because of any restriction, we will notify you in writing.

Bulk waste bins are emptied one day a week, but they can be emptied up to 7 days a week for an extra charge.

The yearly charge applies for each collection day in the same week. For example, a 1,100 litre waste bin emptied 2 days a week is \$4,938 a year.

Bulk recycling bins are emptied one day a week only. Extra service days aren't available.
